1. Reporting required under Condition 14

1.1 Condition 13.1 (a)

Clearing commenced on the 17/05/2022 and was completed on the 21/05/2022. Refer to Figure 1 for zones cleared and date of clearing for each zone. 1.9 Condition 13.1 (i)

As of 31/01/2023, V&V Walsh have placed a conservation covenant over area shaded orange in figure 3 of schedule 2 in CPS 9219/1.

1.10 Condition 13.1 (j)

Revegetation as per the *Revegetation Plan* commence in March of 2023, with site preparation being undertaken for the first 18 months and planting scheduled to commence in autumn 2024.

Revegetation preparation commenced in March 2023. Several weeding control and seasonal monitoring events were undertaken throughout 2023 to prepare the site for planning of vegetation in autumn 2024. Planting occurred in autumn 2024. Monitoring and weed management continued throughout 2024.

2. Condition 14 Summary

As per condition 14 (a)(ii), no clearing activities were performed in the preceding calendar year of January 1 to December 31, 2024.

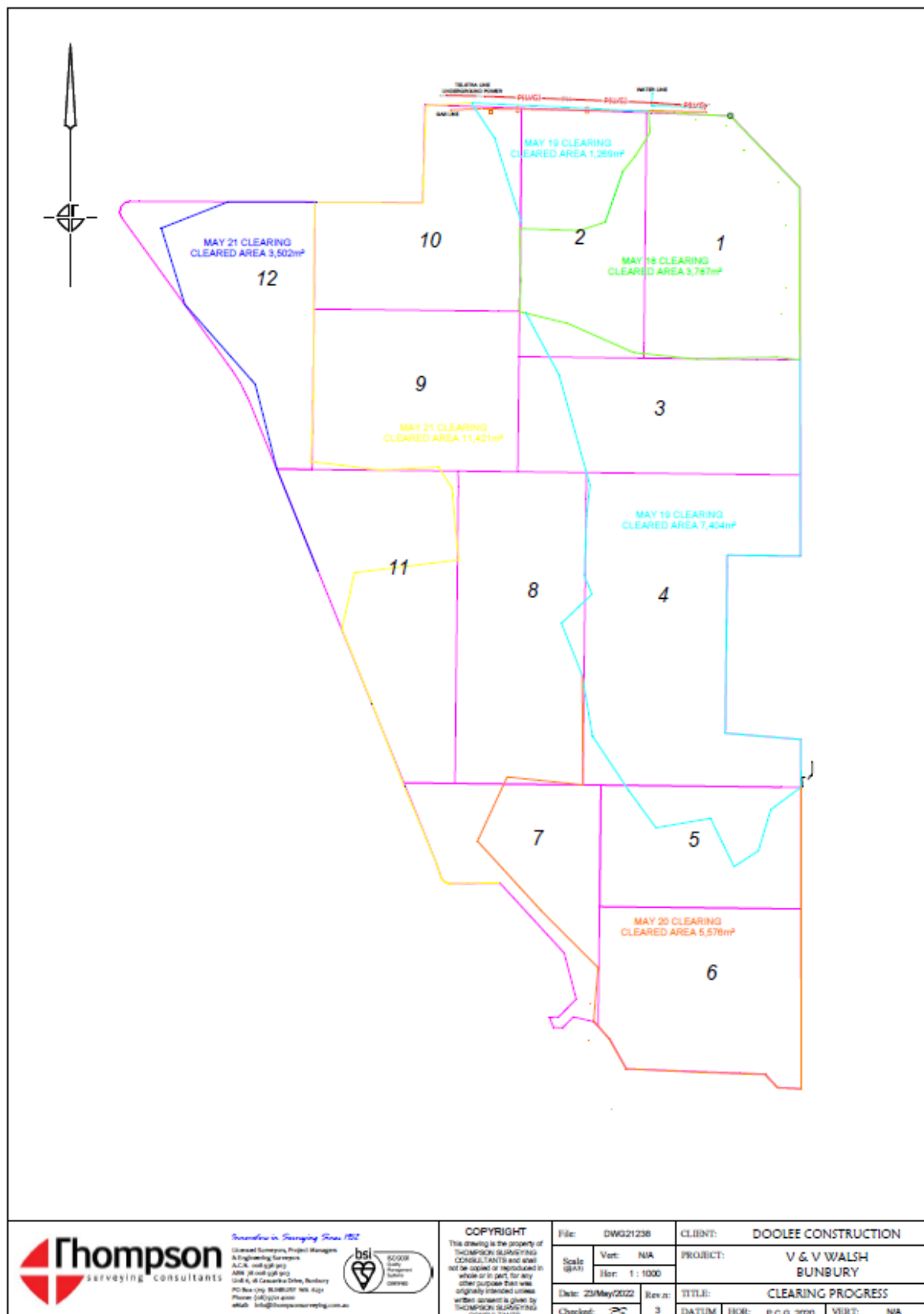


Figure 2 – Deposit Plan 422707
